Fees for commonly lodged documents

This information sheet summarises the statutory fees payable for the most commonly lodged documents. It also advises the lodgement periods, if applicable. Fees are also shown on the guide that accompanies printed forms.

Fees are determined by:

- the Corporations (Fees) Regulations 2001;
- the Corporations (Review Fees) Regulations 2003;
- the National Consumer Credit Protection (Fees) Regulations 2010;
- the Business Names Registration (Fees) Regulations 2011; and
- the Superannuation Auditor Registration Imposition Regulation 2012.

These fees are not subject to GST.

Some forms can be lodged electronically—see www.asic.gov.au/forms for details.

Please note that this is a summary giving you the basic information you need. It does not cover the whole of the relevant law and is not a substitute for professional advice.

Please note also that because this information sheet avoids legal language wherever possible there may be some generalisations about the application of the law.  - (i) is formed for the purpose of providing recreation or amusement or promoting commerce, industry, art, science, religion, charity, patriotism, pension or superannuation schemes or any other object useful to the community; and
 - (ii) applies its profits (if any) or other income in promoting its purpose; and

- d) a company the constitution of which:
